


Health Care Private Employment Share of Total Montana Economy, 2007




Health Care Private Employment Share of Total Montana Economy, 2009






Only a few states devote more of their GDP to health care



Health care employment growth remains positive




Composition of health care employment in Flathead

Montana





Who Pays Depends on What We're Buying


Medicare's Share of Total Personal Health Care Spending, est. 2011

Share Total Health Care Employment, by Sector, 2009 (61,569)




Where Do Montana Hospitals Get Their Revenue?


Share Hospital Revenue from Medicare, 2009

Medicare and "the experienced" Population Match Almost Perfectly


Medicare Funding by County


Medicare Spending/65 and Older Population

43% of jobs in Hospitals

Montana Hospital Outlook

- PPACA impact: 64%uncertain, 28% unfavorable
- Increased use of mid-levels (90%)
- Marcus Welby effect (92%)
- Future of ACO's uncertain (64%)
- Staffing
 - Increase need for nurses, physicians, paraprofessionals and laboratory
 - No change in imaging and ancillary
- Challenges: workforce, capital
