#### Mining and Taxes

Mining's considerable contribution in Montana is reflected in its tax bill, as well as in substantial payrolls and multi-million dollar expenditures for goods and services.

For the year 1971, our taxes in Montana ran at a rate of \$30,000 every day — a total \$10,953,586. Property and net proceeds of mines taxes amounted to \$8,987,151 Additionally we paid to the state last June a record metal mines tax of \$1,975,435 based on the gross mineral production of the Butte mines in 1970. On this tax there's no allowance for mining costs, depreciation or other expenses.

Counties sharing in the larger property tax payments are: Silver Bow, \$4,923,683; Deer Lodge, \$1,410,062; Flathead, \$1,258,985; Cascade, \$787,064 and Missoula, \$391,969.

It is noteworthy that nearly \$6,000,000 of the company's property taxes will go for education of our Montana young people.




